For example, using Bridge with SQL Server Express will only allow an import of approx. 10,000 new Products (Loan or Deposit) due to 10 GB size limit of SQL Server Express.

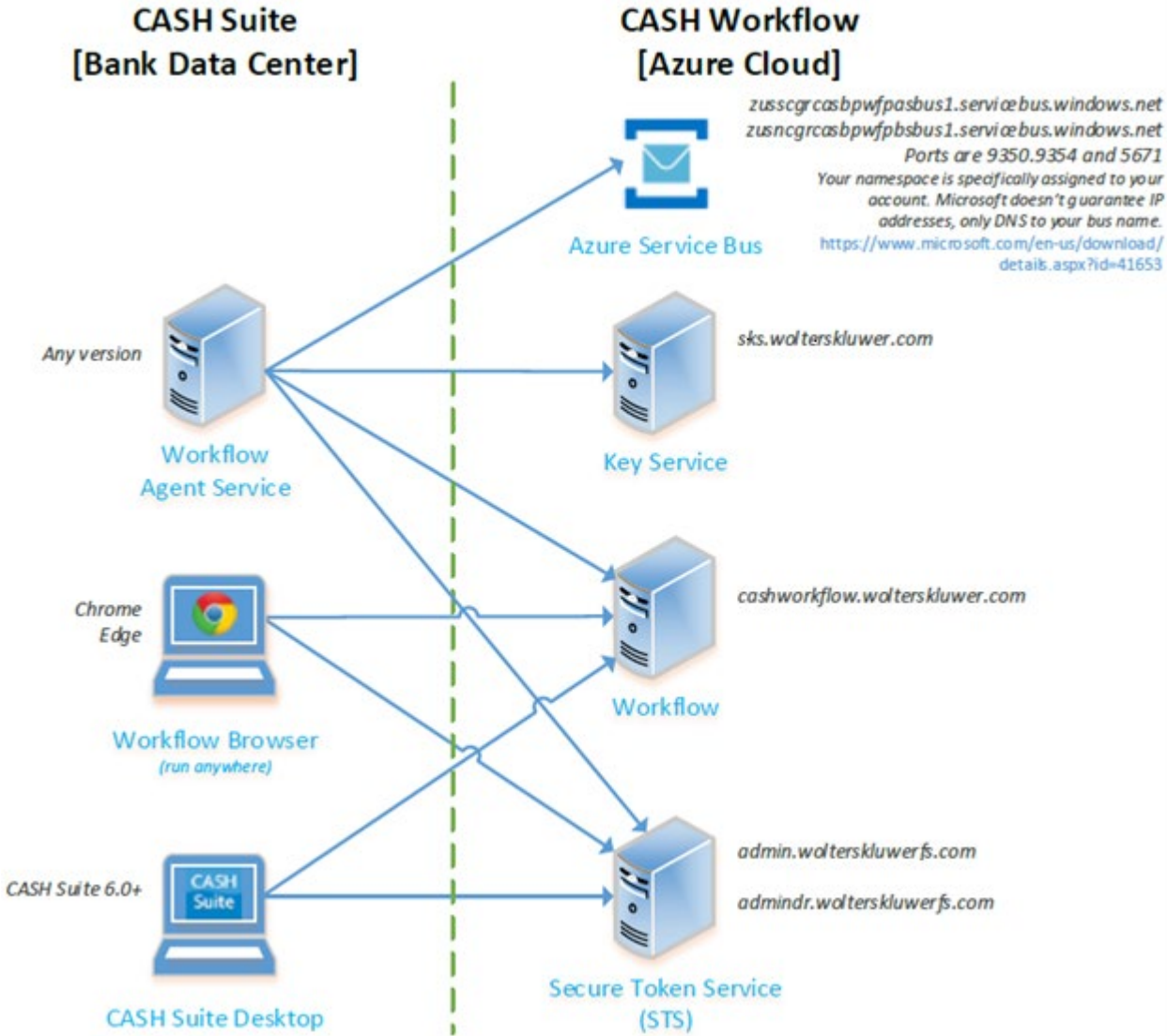
