- For integrated lenders, the default disclosure value is **30/360**. An integrated lender now also has the option the request it to be changed for them to **Actual/365**. They can do so by contacting our SupportLine at support@appone.net.
- For non-integrated lenders, the default disclosure value is **Actual/365**. A dealer and/or service company now also has the option the request it to be changed for one or more of their non-integrated lenders to **30/360**. They can do so by contacting our SupportLine at support@appone.net.
