When the **Class Type** is **Class A**, **Class A Diesel**, **Class B**, **Class B Diesel**, **Class C**, or **Class C Diesel**, the **Body Style** field populates as **MH**. When the **Class Type** is **Travel Trailer**, **Fifth Wheel**, **Tent Camper**, **Park Model**, **Truck Camper**, or **Other**, the **Body Style** field populates as **CT**.
