The following forms of type *Motor Vehicle Titling Forms* were added to AppOne content as new forms.

- *Sales Binder (OR)*.
- BOE-447 Statement Pursuant to Section 6247 (CA) (Revision 11/2008).
- Certificate of Fact for Address Verification - Exception (WA) (Revision 3/2012).
- Affidavit of Loss / Release of Interest / Gross Weight License (WA) ((Revision 11/2014).
- Release of Interest / Power of Attorney (WA) (Revision 11/2013).

### New Titling Form - Outboard Motor Title Application (Missouri) Rev. 06/21/2013

The *Outboard Motor Title Application (Missouri) (Revision 06/21/2013)* was added to AppOne content as a new form. Fields are populated as follows:

- The **Unit** section contains motor information.
- The **Price** and **Net Prices** fields contain the selling price of the motor only, if a motor price is present.
- In the **Trans Type** area, **Outboard Motor** is checked.

### REG 5060 Year Model Disclosure Statement (CA) Rev 7/2004

The *REG 5060 Year Model Disclosure Statement (CA) (Revision 7/2004)*, form type *Motor Vehicle Titling Forms*, was added to AppOne content as a new form.

### Update Mapping of Boat Title Application (Missouri) Rev. 06/21/2013

(Deployed 6/9/2015)

The *Boat Title Application (Missouri) (Revision 06/21/2013)* was updated to populate as follows:

- The **Boat/Vessel License ID Number** field is blank.
- The **Price** and **Net Prices** fields contain the selling price of the boat only, if a boat price is present.
- In the **Trans Type** area, **Boat/Vessel** is checked.

### Update Mapping of Certificate of Title Application (Missouri) Rev. 08/15/2013

The *Certificate of Title Application (Missouri) (Revision 08/15/2013)* was updated to populate the **Price** and **Net Price** fields with the trailer price when the collateral type is Marine and a trailer price is present.
