The *H-13 Official Registration of a Motor Vehicle (CT) (Revision 8/2014)* was updated to always leave the **Section 8. Dealer Transaction, CT Sales Tax Permit No.** field blank.

Update to US Bank RICs - Add "N/A"s to blank lines

The *US Bank Recreation Finance National Promissory Note* and *Security Agreement* and *US Bank Motor Vehicle National Contract 30334* were updated with the following changes:

- On page 1, populate fields in the **For Wisconsin Residents Only** section with **N/A** if neither applicant address state is **WI**.
- On page 2, populate the Credit Insurance signature and date fields with **N/A** if the applicants are not purchasing credit life or disability insurance.
- On page 4, populate the **THIRD PARTY AGREEMENT** signature fields with **N/A** all the time.
