### Dealer Prep Fee

A new fee, **Dealer Prep**, was enabled for marine, powersports, RV, and trailer collateral for Texas, Arizona (PBI #337077), Nevada, and Florida. This fee is not separately itemized on the contract. It is included in the sale price on WKFS contracts, but separately itemized on the WKFS buyer's orders.

### NJ MV Titling Form

The *ST10 NJ MV Titling Form (Revision 6/06)*, form type *Motor Vehicle Titling Forms*, was added to AppOne content as a new form.

### Remove From CBT Batch

The form selection rules were updated to remove the *Guarantee of Title and Additional Insurance* and *Third-party Payment Addendum* from Crescent Bank & Trust (CBT) loan batches.

### Update to mapping of RV types on state titling forms for NC

The *Certificate of Title Application (North Carolina) (Revision 11/13)* was updated to populate the **Body Style** field with HC when the **Collateral Type** is RV and the **Class** is **Class A**, **Class A Diesel**, **Class B**, **Class B Diesel**, **Class C**, or **Class C Diesel**.

### US Bank Credit App

The Tracker Marine Financial Services form selection rules were updated to include the US Bank Credit application in all US Bank funding packets.
