Add Form Selection Rule to all Marine Deals

A form selection rule was added to include *Goods or Services Purchased Addendum RS-GS-ADD (Revision 3/1/2016)* with any marine deal with any lender other than Merrick Bank, Medallion Bank, or US Bank.

Camping World - MA RMV-1

The *Massachusetts DOT RMV-1 Application Form Revision 8/15/2013*, form type *Motor Vehicle Titling Forms*, was added to AppOne content as a new form.

Goods or Services Purchased Addendum
