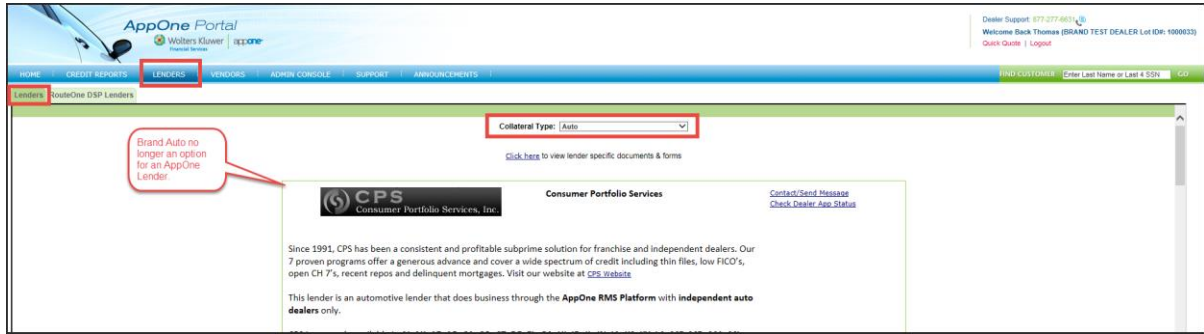

If a dealer tries to include MarineOne GAP insurance with a Colorado deal, the system displays an error message on the **Forms** tab and the dealer cannot print forms.
