We updated the portal to prevent RMS Independent Auto dealers from using the **Rebate** field to enter cash down payments on used vehicles. If a rebate is entered for a used vehicle, the portal displays the following error message and will not proceed:

You have entered a Rebate for a used unit which none of our lenders will accept. Please go to the Structure tab and remove the Rebate field. If the customer is making a cash down payment, it must be included in the Cash Down field instead.
