SR 1417332 - Failsafe for Credit app submit date error (1/1/1900)

In certain rare situations, the credit app date was being communicated to the doc engine as "1/1/1900". The following forms were updated to print today's date if the situation occurs:

- Retail Motor Vehicle Credit Application
- Retail Motor Vehicle Credit Application (3 or 4 applicants)
- Retail Motor Vehicle Credit Application (Maine) (Revision 6/16/2011)
- Retail Installment Credit Application (NV) (Revision 10/01/2012)
