The *Standard Sales Tax Receipt DR0024 (Revision 3/14/05)* was updated so that the **Gross Selling Price** field populates with the sum of the following values:

- Selling price
- Documentation fee
- Selling price of the Paint Protection (paint), Tire Blowout Protection (tireblowout), and Windshield Protection (windshield) back end products.

Update to mapping of IL worksheet

The *ST-556 Worksheet* was updated so that the **Total Price** field populates with the sum of the following values:

- Selling price
- Documentation fee
- Selling price of the Paint Protection (paint), Tire Blowout Protection (tireblowout), and Windshield Protection (windshield) back end products.

Leave field labelled "Permit Number" at bottom of UT MV1 blank

The *Application for Utah Title (Revision 10/18/2013)* was updated so that the **Permit Number** field is left blank and the **Permit Issue Date** field populates with the contract date.

Iowa Title Application

The *Certificate of Title Application (Iowa) (Revision 1/25/2013)* was updated to uncheck the **Ownership Status: OR** box and to leave the **Authorized Representative & Title** field blank (previously, **Authorized Representative & Title** was populated with the salesperson's name instead of populating Salesperson name).

All outdated contracts were removed from the AppOne production environment.
