The *Title and Registration Application (AZ) (Revision 12/13)* was updated to populate the **Total Fees** field with the sum of the title fee, registration fee, and lien fee.

The *ADOT Power of Attorney (Arizona) (Trade-In)* was added to AppOne as a new version of *ADOT Power of Attorney (Arizona)*. The new version populates with information from the trade-in unit,
