The *Odometer Disclosure Statement MVR180 (Revision 5/89)* was updated to populate with the F&I person's name, not the salesperson's name.

The form selection rules were updated to select the *Buyers Guide (Implied Warranties) (Revision 6/1/2015)* instead of the *BSI Buyers Guide (General- English Version)* for Massachusetts. The rules still selects the *BSI Buyers Guide (General- English Version)* for all other states.

Update to mapping of RV types on state titling forms for NC

The *Certificate of Title Application (North Carolina) (Revision 11/13)* was updated to populate the **Body Style** field with HC when the **Collateral Type** is RV and the **Class** is **Class A**, **Class A Diesel**, **Class B**, **Class B Diesel**, **Class C**, or **Class C Diesel**.
