- In the **Evidence of Ownership** field, if the unit is new, the form populates with **MCO**. If the unit is used, the field remains blank.
- In the **Applicant acquired said motor vehicle by (state how acquired)** the form always populates with **PURCHASE**.

The *BSI Disclosure of Equity in Trade-in Motor Vehicle (Texas) (Revision 01/29/2010)* was updated to leave the **Amount Financed** deal blank for a cash deal.
