- **Reference:** PBI 340216
- **Compliance Impacts:** This defect is a compliance or regulatory issue.

Issue

An error was identified in the DocPrep to Document Generation Services integration where a document name was appearing incorrectly in the forms list. A document was being listed in the forms list even though it was not being returned as a document in the DocPrep package.

Solution

This issue has been resolved; the list now contains the form names that exist in the PDF.

Incorrect Expere/TRID documents issue resolved

- **Reference:** PBI 34574
- **Compliance Impacts:** This defect is a compliance or regulatory issue.
- **Documentation:** No documentation impact

Issue

An error was identified in DocPrep that not all instances of the TRID documents produced in Expere were being added to the DocPrep package. DocPrep was only placing the first instance of a given TRID document from Expere.

Solution

This issue has been resolved; the correct number of documents are being added to the DocPrep package when a request produces more than one instance of a TRID document.
