## What's New

### Enhancements

#### Image Updates

#### Summary

This enhancement allows Doc Prep customers to have personalized logos or images placed within their documents, for personalizing the documents to their institution.

These enhancements are exclusive to image updates (glyph files) representing logo images or visual indicators (arrows, text shading) requested to support branding and other design requirements.

- **Added four (4) new images:** WKFS received a request from an institution to support image requirements for new custom forms.
- **Added one (1) new images:** WKFS received a request from an institution to support image requirements for a standard form.
- **Added three (3) new images:** WKFS received a request from an institution to support image requirements for new custom forms.

A total of eight (8) images were requested and are now supported.

### Resolved Issues

#### VMP12ACA Issue Resolved

#### Issue

Issues were located within the scenario calculations, where the input data was being taken from the actual scenario elements in the MDO. The correct functionality should involve executing the calculations based on the main transaction and then copying these results to the actual/results area.

**Solution**

Issues were located within the scenario calculations, where input data was being taken from the actual elements in the MDO. This was changed to take results from the main part of the transaction.

**Implementation Notes**

This feature requires a Document Preparation update.
