## What's New

### PickList in TRID Documents

- **Reference:** PBI 314259
- **Compliance Impacts:** This enhancement is not a compliance or regulatory issue.
- **Documentation:** [Document Preparation Subpackaging User Guide](#)

#### Summary

This enhancement enables the TRID (Int Disclosure) document to be placed within the returned document set and have the TRID documents displayed as part of the subpackaging picklist.

#### Technical Notes

Note the following:

- When using a package that only produces Integrated Disclosure, Document Preparation only returns the Integrated Disclosures.
- The TRID documents (Integrated Disclosures) are replaced in the Document Set when returned from Document Generation Services.
- The TRID documents get returned when specified when using Subpackaging functionality.
- The TRID documents are returned with the Picklist when Subpackaging is used.
- Watermarks can still be specified on the TRID documents.

#### Implementation Notes

This feature requires a Document Preparation update.

### Image Updates

- **Issue:** Logos/images supported on documents
- **Reference:** PBI 310768
- **Compliance Impacts:** This is a compliance issue.

#### Summary

This enhancement allows Doc Prep customers to have personalized logos or images placed within their documents, for personalizing the documents to their institution.

The following image enhancements are being released concurrently with the PROD release. These enhancements are exclusive to image updates (glyph files) representing logo images or visual indicators (arrows, text shading) requested to support branding and other design requirements.

- **PBI 310768 (DDCI-29583, CIER M03.15.01-12) - Added ten (10) new images:** WKFS received a request from an institution to support image and design requirements for new custom forms.

A total of ten (10) images were requested and now supported.

## Resolved Missing Page Numbers

- **Reference:** PBI 298776
- **Compliance Impacts:** This defect is not a compliance or regulatory issue.
- **Documentation:** No documentation impact.

### Issue

It was discovered that page numbers 2A and 2B on the Integrated Disclosure document (Closing Disclosure) were not being printed.

### Solution

Previously, when the documents were merged into one PDF, the page numbers were being dropped. Now, the PDF is being flattened before the documents are merged, which retains the page numbers.

### Implementation Notes

This feature requires a Document Preparation Runtime Engine update.

## Additional Check for DocPrep Integrated Disclosure Documents

- **Reference:** PBI 324052
- **Compliance Impacts:** This enhancement is not a compliance or regulatory issue.
- **Documentation:** No document impact.

### Summary

This enhancement adds an additional check to get different versions of documents associated with TRIDs and DocPrep.

### Technical Notes

An additional check was placed in Document Preparation for TRID documents to look for a TXN node in the transaction schema prior to sending the request to Document Generation Services. Code now verifies that both the Integrated Disclosure flag is true and the TXN node is present.

### Implementation Notes

This feature requires an Expere Engine update.
