### MULTI-STATE

#### Housing Counseling Agencies Notice

The Housing Counseling Agencies Notice is not required to be issued for temporary loan transactions where the lender has not offered a commitment to provide temporary financing or for bridge loans (12 C.F.R. 1024.5(b)(3)). That is why the document will no longer select if either the **Bridge Loan** or **Temporary Financing** indicator is selected under the Note section within the Document Data page.

#### Mortgage Interest Statement 1098

The Mortgage Interest Statement 1098 has been updated to follow the IRS model form. '2019' has been updated to '2020' throughout the form along with additional minor changes to the Instructions sections.

### GEORGIA

#### Motor Vehicle Title Application-GA

The Motor Vehicle Title Application-GA has been completely revised to match Georgia Department of Revenue form MV-1 with a revision date of 10-2018. The changes are the following:

- The form has been updated to include the Instructions page making it a two page document;
- The Email Address and Phone # fields have been added to the Owner section;
- The Name & Mailing Address of Attorney-In-Fact has been broken out from a single field that collected the name and address together into separate fields for each. In addition, the Email Address and Phone Number fields have been added to the Attorney In Fact Information section;
- The look and feel of the document has been updated to match the model form.

### KENTUCKY

#### Recordable Documents

The documents have been updated to follow the PRIA Real Estate Document Formatting Standards, that is why the following formatting changes have been implemented:

- First page top margin is 3";
- Last page bottom margin is 3";
- All other margins are 1".

### WYOMING

#### Motor Vehicle Title Application-WY

The Motor Vehicle Title Application-WY has been revised to match State of Wyoming form 300A with a revision date of 01-2018. The updates include:

- The new fields - Vessel Length and NMVTIS (National Motor Vehicle Title Information System) have been added;
- The following fields have been deleted - Propulsion, Engine Drive and Hull Material;
- Language changes have been made throughout the document to match the model form.
